2.	<b>2016 tax ceilings and Chapter 313 limitations.</b> A. Enter 2016 total taxable value of homesteads with tax ceilings. <b>10.</b>	<p><b>Total adjustments for lost value.</b> Add lines 7, 8C, and 9C. <span style="float: right;">\$1,048,171</span></p>	\$1,048,171
<b>11.</b>	<p><b>2016 adjusted taxable value.</b> Subtract line 10 from line 6. <span style="float: right;">\$67,523,928</span></p>	\$67,523,928
<b>12.</b>	<p><b>Adjusted 2016 taxes.</b> Multiply line 4 times line 11 and divide by \$100. <span style="float: right;">\$923,322</span></p>	\$923,322
<b>13.</b>	<p><b>Taxes refunded for years preceding tax year 2016:</b> Enter the amount of taxes refunded by the district for tax years preceding tax year 2016. Types of refunds include court decisions, corrections and payment errors. Do not include refunds for tax year 2016. This line applies only to tax years preceding tax year 2016. <span style="float: right;">\$0</span></p>	\$0
<b>14.</b>	<p><b>Adjusted 2016 taxes with refunds.</b> Add lines 12 and 13. <span style="float: right;">\$923,322</span></p>	\$923,322
<b>15.</b>	<p><b>Total 2017 taxable value on the 2017 certified appraisal roll today.</b> This value includes only certified values and includes the total taxable value of homesteads with tax ceilings (will deduct in Line 17). The list shows the district's value and the taxpayer's claimed value, if any, or an estimate of the value if the taxpayer wins. For each of the properties under protest, use the lowest of these values. Enter the total value.</p>	\$0	
	<p><b>B. 2017 value of properties not under protest or included on certified appraisal roll.</b> The chief appraiser gives school districts a list of those taxable properties that the chief appraiser knows about but are not included at appraisal roll certification. These properties also are not on the list of properties that are still under protest. On this list of properties, the chief appraiser includes the market value, appraised value, and exemptions for the preceding year and a reasonable estimate of the market value, appraised value, and exemptions for the current year.
